- B. Facility Improvement: John B. reached out to Eill and he shared that the architects are backed up. Estimated an end of 2023 or 2024 construction timeframe. Remodel is looking to be around \$4M cost, and John has multiple grants stacked to cover the cost.
- C. Hazmat Trailer: John B.: Katie is working on the logos for it. Casey, Zane and Katherine are putting it together and organizing it.
- D. Halloween: John B.: We gave out less candy than last year. NFPD received numerous compliments on the effort.

- B. The recent S131 WL training was a success we had a total of 14 students with 8 of them being SMCS deputies. The field day was held at John B. residence. Students were hiked into the woods and worked on mock fires. Grid training was performed and shelter deployment training was provided. Joe from DFPC was on hand. Britney Wolf, Josh Hill, Mike Price all helped with training.
- C. John B. shared that he received Mark G. and Eric Farr's evaluation from the Mosquito Fire supervisors. They received "Superior" marks. John shared when Mark and Casey go out those are the marks they usually receive.
- D. John B. shared that he also received a nice letter from Sherriff Bill Masters stating that the deputies really enjoyed the training and it was very professional.
- E. Casey G.: Mark just returned from an Advanced Faller Training. He shared it was an amazing experience and he learned a lot and plans to pass on the knowledge. John B. added that Mark plans to host a saw class in the spring for all members. End of Mark G. report.
